Also present was Executive Director Miletic and Superintendent of Business Barbara Barrera.

PERSONNEL

A review of positions and titles was discussed; there was only one job title change to meet the standard in the market place. Also ranges were adjusted by 2.1% which was the CPI.

A spreadsheet with each individual's salary was presented to the park board and discussion of a 3% merit pool was discussed. It was also discussed that three of our staff are at the maximum in their range and will only get adjustments based on how much the range is increased.

The park board was brought up to speed on staff's great efforts in decreasing health care costs. In addition, with those savings they suggested providing a benefit for our staff that currently has more than employee coverage in dental. Currently our employees have to pay the difference of the employee only coverage and any additional family member added. This change provides some relief to the employee and the Park District will still have an overall decrease by implementing this benefit to our employees.

There was discussion by the park board on all the items and staff answered questions.

LEASES & LICENSE AGREEMENTS

Executive Director Miletic informed Park Board about the leases at 1340 Oakwood and that our former employee is still interested in renting till he cleans out the space. He comes into town once a month and currently uses it for storage after the passing of his mother. Recommendation is to leave the amount at \$1142 per month. The property is very dated and is between two maintenance facilities and will eventually be torn down.

Executive Director Miletic informed the Park Board of 630 Greenview which is currently being rented by an employee. Our policy for employees is to rent at 70% of market value as long as they are monitoring the adjacent park. This residency is next to West Park and the rental amount is \$1,290 per month.

Executive Director provided the Park Board information about Awesome Worke Sports Inc. that is licensing our space at the Golf Center. He presented information of a 4% annual increase and informed the tenant of this amount and they have agreed.

PERSONNEL

The Park Board asked Executive Director Miletic to leave the room to discuss his performance and renewal of contract. This was at 9:15pm. Executive Director was asked to return to Executive Session at 10:00 pm and his review was given and Park Board was happy with his performance and all the updates across the District. They informed him the contract, which is set to expire in 2019, will be renewed as a new contract from May 1, 2018 – April 30, 2021. In addition, a 6% increase will be given to \$162,180 and \$50 a month for car allowance increase.

There were great ideas shared by the commissioners and consensus is to move forward with this position and have the Executive Director keep the Park Board informed.
