## LITIGATION

Executive Director Miletic did update the Park Board that the Park District has a large file of information to go over, as the Frunza Case was not dismissed based on the tort immunity law. The new judge in the case has asked for additional information and PDRMA is working with investigators to find out more information. We continue to do what PDRMA tells us to and following up with what is needed.

#### LAND

The Park Board was informed of the market analysis of 1355 Oakwood Property and the value coming in at \$220,000. Executive Director Miletic said that he was unable to negotiate with the owner until we receive a waiver of retroactivity from the IDNR as any negotiations prior would jeopardize the grant. The Park Board gave consensus to proceed with acquiring the property at the market analysis figure.

### **BOARD DIRECTIVES**

Executive Director Miletic reviewed the Board Directives spreadsheet in detail line by line with the Park Board. Miletic explained he is staying removed from lower level items and is very happy with the organizational chart and the team he has in place. Miletic explained we have an A-Team right now in the administrative side and even our maintenance side, which is not requiring hands on attention. Weber is doing great, has some challenges but is on the same page with Cathey and myself and this allows Miletic to work on larger projects. President Haas commented it is good to see Miletic removed from micromanaging and getting away from this. Commissioner Doerr said she is new to this and understands that staff such as Cathey and Weber should be careful with the sensitive staff member. Commissioner Grady said he likes seeing the spreadsheet and all the updates. Commissioner Rosedale asked how things are going with Miletic and sensitive member, and Miletic replied he does not communicate with her one on one as directed and as for personal settings, Miletic will speak with her only if there are others present like Cathey or Weber. President Haas also said to review this with Commissioner Yates. Miletic did review with Commissioner Yates on October 30, 2019.

Executive Director Miletic thanked Park Board for support and reiterated he could not be happier with how things are going now. We continue to make large improvement for the community.

### **PERSONNEL**

An issue with a maintenance staff getting a DUI on his time and PDRMA recommendation for this employee. Executive Director indicted that PDRMA wanted the District to remove this person from employment because his job description required him to drive. Miletic informed Park Board this is a long time employee with great performance that made a dumb decision to drive impaired. In addition, if the State of Illinois gives him a temporary license to operate a motor vehicle we do not see an issue with this employee. PDRMA looks at liability and not operations. Miletic indicated we will take into consideration how to handle this and stressed with current unemployment levels we cannot afford to lose a great employee. In addition, we will use Corporate Council as our personnel resource versus PDRMA for future matters.

Executive Director Miletic spoke about two employees that have gone beyond expectations. The two employees were given additional pay for their outstanding completion of tasks and for market adjustments due to low unemployment. Commissioner Grady did state it is tough hiring people and people can get a 10% increase because of the economy. There was feedback on the level of increase and it was determined to give Nicole McNulty an increase to \$71,000 and Jeanette Berrard and increase to \$68,000. The Park Board all said to thank these two for their hard work from the Park Board of Commissioners.

#### LITIGATION

The Frunza case will go to trial on the October 16, 2019 and should last about a week. Miletic explain he will be gone next week at court, except for the Distinguished Agency Review on October 22,2019.

There was some discussion about the Feather Property becoming condos, we also discussed housing in Des Plaines and its impact.

### **PERSONNEL**

Executive Director discussed the positive benefit of the DISC Assessment with his admin team. In addition, discussion about some of our more passionate staff in Admin, Miletic did say it is a refreshing as we need more of that and is working with all staff. In addition, the great work by our new Superintendent, jumping in with two feet and doing what is in the best interest of the community. Business Department is working on a climate survey, Miletic is concerned that some will reflect negative comments but is very positive about direction we are heading in. We have an Admin Team that wants to work on making things bigger and better. The Park Board went back and forth about how there will always be a few that will not like things.
