I was not aware and then Superintendent Panek was approached. We had discussions with a potential new buyer that wanted to move quickly and was talking to current owner of Club Casa. I said we would bring this to the Park Board and also discuss a recommend figure for the License Agreement. We indicated there will be a large increase due to inflation and high costs of utilities. Currently the monthly rent is way under market.

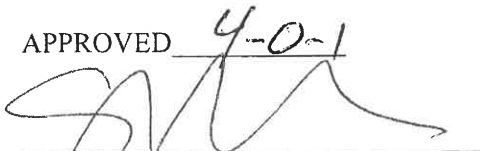

We felt comfortable if they want to transition to Club Casa except for terms. Club Casa owner did indicate to potential buyers, he wishes to simplify his life and get out of one business and has been making good profits at Club Casa.

PERSONNEL

Executive Director Miletic gave an update about the salary adjustment for Landscape Department. There is a supply and demand issue and Miletic presented adjustments that were worked on by Human Resource and himself for this department. There has been a few years that we have

struggled to maintain staff and this adjustment will give this department a good balance compared to area park districts.

President Doerr reviewed summarized annual review from Commissioners that was provided to her by Andrew Paine the Park District Attorney and comparable Executive Director pays received from other park districts in the area. Doerr presented and complimented how well the District is going, Commissioner Grady commented on the huge amounts of grant dollars that were brought in with Miletic as the Executive Director and how running a tight ship is how we have gotten here. Commissioner Rosedale mentioned the Miletic's efforts in grant funding does not get enough credit. Commissioner Eli expressed he likes all the park district is offering and has seen and paying fair to other district is important, as we did for landscape. The recommendation was to give a 4.5% increase and a 4.55% market adjustment which would place Executive Director Miletic, in the lower portion of the top 13 Executive Directors in the area based on performance and over 12.6 million dollars in grants.

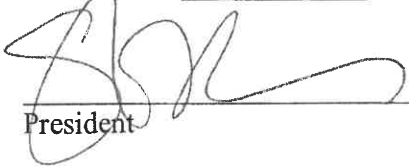
Executive Director briefly mentioned a 7% salary pool coming to bring salaries up to levels within other park districts. These figures will be coming in February meeting, along with promotions.
